Angie:

This e-mail is a follow-up to my previous e-mail (attached) and conversation with you early last week via phone regarding the format of your findings specific to the Biological Assessment (BA) you recently completed for the Creekside Memorial Park Cemetery Project.

To address the comments received from the DEIR, please provide your data in the following format:

- Prepare a Stand Alone Memo specific to your findings related to the VELB, including a map of elderberry shrub locations overlain on a map showing project modifications such as Figure 3 from the draft BA;
- Prepare a second Stand Alone Memo on your opinion regarding Aquatic Invertebrates (to address DEIR comments received) including a larger scale Map of the location of these species, (which we should already have, but in a more readable format adequate for addressing direct and indirect impacts);
- Provide a Letter that describes your historical knowledge of past technical assistance during preparation of the Biological Assessment, including coordination and consultation with the USFWS and CDFG that have provided DEIR comments to address their concerns;
- Prepare a Letter summarizing your assessment of past Biological reports validity, and clearly identify what could and/or could not be considered valid based on the time of year your recent site visit was completed. Also, describe your past experience related to successful translocation and establishment of Congdon's tarplant, and provide a reference document that can be made available for the public to review that demonstrates success such as the Annual Monitoring Report for the Congdon's tarplant mitigation.
